## **Confidentiality and Privacy**

Confidentiality is of enormous importance to me, and I take it very seriously. I have worked with protected health information (PHI), governed by HIPAA, and have completed numerous training and compliance programs required to work with such data. Outside of PHI, I apply a high level of protection to a client's data, and do not reveal my relationship as a consultant with the client unless expressly wished by the client.

All data files that I receive from clients for statistical analysis are encrypted, and retained on a private/personal computer. In data transfers, data are always encrypted and password protected.

## **Fees**

My rates are often negotiable and depend on numerous factors, such as the level of expertise required and timing. I may charge either hourly or by the project, depending on the client's preference. I offer services on a sliding scale for students and non-profits. For basic analyses and general consulting projects, my hourly rates start at \$125. For statistical reviews and specialized consulting or training, my hourly rates start at \$150.
